

**LEGAL DESCRIPTION OF  
LOT 13 OF KONA VIEW ESTATES**

All of that certain Property being a portion of Royal Patent Number 7587, Land Commission Award Number 11216 and L.C. Award 9236, Apana 36 to M. Kekauonohi (Certificate of Boundaries No. 138), situate at Honokohau 1st, District of North Kona, Island, County and State of Hawaii, containing an area of 1.00 acre, more or less, and thus bounded and described as per survey as follows:

Beginning at a set ½ inch rebar with a red plastic cap marked No. 10743 at the Northeast corner of this herein-described lot, being the inner West corner of Lot 12 of this subdivision, the coordinates of said point of beginning referred to Government Survey Triangulation Station "MOANUIAHEA" being 18,539.13 feet South and 7,934.60 feet West and running by azimuths measured clockwise from True South:

          Thence along the remainder of R. P. 7587, L. C. Aw. 11216, Apana 36 to M. Kekauonohi. (Certificate of Boundaries No. 138) with the following six (6) courses;
4.    **75° 50' 00"**    **49.60**    feet along TMK (3) 7-4-008:060 to a found pipe in concrete;
5.    **120° 58' 22"**    **136.63**    feet along Lot 23 of this subdivision to a set ½ inch rebar with a red plastic cap marked No. 10743;  
  
          Thence along Road Lot C (Waiha Street) with the following two (2) courses;  
  
          Thence along a curve to the left with a radius of 45.00 feet, the chord azimuth and distance being:
6.    **158° 13' 33"**    **49.47**    feet to a set ½ inch rebar with a red plastic cap marked No. 10743;  
  
          Thence along a curve to the right with a radius of 40.00 feet, the chord azimuth and distance being:
7.    **144° 56' 25"**    **27.44**    feet to a set ½ inch rebar with a red plastic cap marked No. 10743;  
  
          Thence along Lot 12 with the following two (2) courses;  
  
          Thence along a curve to the right with a radius of 10.00 feet, the chord azimuth and distance being:
8.    **210° 00' 00"**    **14.14**    feet to a set ½ inch rebar with a red plastic cap marked No. 10743;
9.    **255° 00' 00"**    **276.00**    feet to the point of beginning and containing **an area of 1.00 acre.**
